  - 1. Chancellor—Robin G. Cummings

Dr. Cummings made several announcements about activities on campus, most notably a debate organized by the Student Government Association with candidates for the Robeson County School Board. He reminded the Senate that the UNC Board of Governors would meet the following day (March 3, 2016) at Fayetteville State University. The System President, Margaret Spellings officially assumed her duties on March 1, 2016 with a pledge of focus on education as a civil right emphasizing affordability, access, accountability, and service as driving values for the UNC system. President Spellings will be on campus on March 18, 2016 to meet with small groups of stakeholders. He urged the Senate to vote for the N.C. Connect Bond, which will appear on the upcoming elections on March 15, 2016. He also discussed several partnership programs at universities for veterinary medicine and engineering.

2. Provost and Vice Chancellor for Academic Affairs—Zoe Locklear Dr. Locklear announced the successful reaccreditation of the Athletic Training program, thanking senators, Beverly Justice and Susan Edkins for this accomplishment. The Provost noted that the searches for college deans were progressing, and that at least one dean—that of the School of Business—had been selected.

### E. Reports of Committees

- 1. Operations Committees
  - a. Executive Committee—Scott Hicks

Dr. Hicks stressed that the Executive Committee continued their dialogue with the Provost on the policies and implementation of the Clery Act and Title IX compliance and the future of changes in the process of promotion and tenure made by the previous Chancellor, Kyle Carter, and previous provost, Ken Kitts, that have never been implemented. He solicited the Senate's advice on whether to proceed with these changes or to recommend rescinding them given the departure of Chancellor Carter, Provost Kitts, and all evaluating deans, and he questioned whether faculty support existed for their implementation. Dr. Hicks also discussed the impact of House Bill 97, a deferred admission program titled the North Carolina Guaranteed Admission Program (NCGAP), legislation aimed at raising the sixyear graduation rates. NCGAP requires a student who satisfies the admission criteria of a constituent institution, but whose academic credentials are not as competitive as other students admitted to the institution, to receive deferred admission and enroll in a community college in this state and earn an associate degree prior to enrolling as a student at the constituent institution. Dr. Hicks noted that this would adversely affect UNCP by deferring up to 25 percent of students admitted—most of whom were minority, disadvantaged, or first-generation college students.

Dr. Hicks also discussed a legislative draft bill referred to as the "Berger Bill" Access to Affordable Education Act (2015-LH-170) requiring a reduced tuition rates for freshman students admitted to UNC Historically

Black Colleges, UNC Pembroke, and UNC Ashville that would require certain UNC campuses to drastically reduce tuition (\$500 in state and \$2500 out of state) charged to students, a possible threat to these campuses' financial viability. He concluded his remarks by reminding the Senate of the reception on shared governance that will be hosted by the Student Government Association on April 6, 2016.

## F. Faculty Assembly Report - David Nikkel

Dr. Nikkel began by reporting that the new state budget director was receptive to General Administration's proposal for a 2% increase in the pool for faculty compensation in next year's budget due in part to the mounting pressure on the Board of Governors in the wake granting salary increases to some Chancellors. Dr. Nikkel also reiterated points made by the Senate Chair above regarding the NCGAP legislation. The NCGAP legislation mandated a joint report from General Administration and its community college counterpart on the effects of mandating that some those admitted to UNC System universities attend a community college before enrolling in a four-year university. The report indicated that students do better in achieving a baccalaureate degree by attending a four-year institution rather than by beginning at a two-year institution. Such findings undermine one of the NCGAP goals to increase the proportion of students earning a bachelor's degree.

Dr. Nikkel also stated that Faculty Assembly Chair, Stephen Leonard reported that, at the Board of Governors retreat, President Margaret Spellings indicated that the Board of Governors and the legislature should respect the institutional autonomy of the System's universities, rather than trying to micro-manage the campuses. Finally, the Assembly declined the option of having Chair Leonard write a letter supporting the passage of the NC Connect bond issue, the prevailing sentiment being that such a letter would only have a marginal impact on the vote while alienating some legislators.
