## Using Academic OneFile

**Access:** Go to the Library's homepage at [www.uncp.edu/library/](http://www.uncp.edu/library/). Click **Electronic Resources**. Click **Database Title**. Click the letter **A** and you will see a list of databases. Click **Academic OneFile**.

**Basic Search:** The basic search screen comes up automatically when you open the database. The default search is set to **Keyword**, but you may also select **Subject** or **Entire Document**. Enter your keywords in the **Find** box and click the **Search** button (see image below). You can combine keywords by using **and** (e.g. **obesity and children**). You can interchange different words with similar meaning (such as 'teen' and 'adolescent') using **or** (e.g. **teen or adolescent**). You can also truncate words with an asterisk (e.g. **child\*** = childhood, children, and childs).

**The Results List:** Articles in the results list are arranged by date published with the most recent articles listed first. The list displays 20 results on each page. To see the next page of results, click the **Next** link. Full-text articles are listed as **Full-text**, **Full-text with graphics**, or **# of PDF page(s)**. Full text articles can be printed, e-mailed, or saved to a disk by clicking the **Print**, **E-mail**, or **Download** links. Article citations that do not contain the full text of the article can be identified by the **Check Journal Finder for full text availability** link on the results list (see image below).

**Article Citations:** Citations to articles contain important identifying information, such as the author, title, and publication information. Click **How to Cite** for information on citing the article in your paper. Article citations usually provide subject headings and abstracts (summaries) to help you evaluate articles for relevancy to your topic (see image below). Click **Results** to go back to the list.

Click Subject Terms For Similar Articles

**Journal Finder:** To see if an article is available in full text, click **Check Journal Finder for full text availability** (see image above). Use the icons in **Journal Finder** to determine where to locate a full-text copy of the article.

**Advanced Search:** Click the **Advanced Search** tab at the top of the screen in order to combine and experiment with various sets of keywords. For example, if you were researching the 'impact of funding on congressional elections,' then you would use the first box to enter the main keywords (**campaign finance** or **fundraising**) and the next two boxes to add specific concepts, such as **election\*** and **congress** (see image below).
