RE: Procedure for Vacancy Election of Faculty Senate Chair

Dear Members of the Executive Committee,

The Committee on Faculty Governance convened for our regularly-scheduled meeting on Tuesday, September 22. In addition to our planned business, we discussed procedures related to replacing a senate chair mid-term. The committee recognizes the lack of guidance in the *Faculty Handbook* when a Senate Chair resigns. We further appreciate the complicating issues related to COVID policy, both at the university and in the State of North Carolina.

The Committee on Faculty Governance prescribes the following procedure for the election of a new Senate Chair at the October 7, 2020 meeting of the Faculty Senate:

- The Senate shall elect from its current elected membership a Chair of the General Faculty who shall also serve as Chair of the Faculty Senate.
- The election shall be conducted under "New Business" by the Committee on Committees and Elections (CCE) using live <u>anonymous</u> balloting with controlled distribution to all Senate members. Nominations shall be allowed from the floor.
- Each member of the CCE present at the meeting must verify the results before the CCE chair announces the results.
- The newly elected senate chair will assume office immediately, presiding for the remainder of the meeting.

The Committee of Faculty Governance will provide additional counsel if a chairperson is not elected at the October meeting. Still, a permanent chair's election will remain on the Senate agenda until the office is filled. The Senate Chair pro tem remains acting chairperson until the Senate elects a new chair. We believe it is crucial to the faculty and the university's good-functioning to elect a permanent chairperson in a timely fashion.
