- I. Call to Order
Meeting called to order at 3:31PM by Jesse Peters.
- II. Approval of Minutes of Sept. 15, 2015
The minutes were approved unanimously.
- III. Approval of Agenda
The agenda was approved without additions or corrections.
- IV. Report from the Chair
Chair Jesse Peters welcomed Frankie Denise Powell as the newest committee member. Chair Peters announced that the Faculty Senate approved the attendance policy. Discussion of the progress in the search for President of the UNC system. Chair Peters will attend the upcoming meeting of the UNC Faculty Assembly. Chair Peters reported a request from Aaron Vandemeer to review the Faculty Handbook for language that needs clarification regarding divisions, departments, and areas. This item will appear on the agenda for the next committee meeting.
- V. Unfinished Business
 - A. Further discussion of recommendations regarding the formation of a faculty advocate committee and/or an ombudsperson position at UNCP: Committee members discussed possibilities including feasibility of a funded position, collaborating with other campuses to share a funded position, using UNC Chapel Hill's services, and formation of a committee of former members of related Senate committees. David Nikkel will draft language for consideration at next meeting proposing a new committee of former members of related Senate committees.
 - B. Continued discussion of matters pertaining to shared governance: Chair Peters and Senate Chair Scott Hicks will arrange a small group meeting with Chancellor Cummings and Provost Locklear to review the principles of shared governance document endorsed by the UNC Faculty Assembly in 2005.
- VI. New Business
 - A. Motion recognizing Beverly Justice's contributions to UNCP during her time as chair of the Governance Committee: Beverly Justice served for 4 years as Chair of Faculty Governance Committee. David Nikkel made a motion to approve the recognition; motion was

seconded by Stephen Bukowy. Discussion of amended language (Appendix A). Motion carried with amended language.

B. Discussion of the possible formation of new senate subcommittees as requested by the Senate Executive Committee: Discussion of requests to form new Faculty Senate Subcommittees related to the writing intensive programming developed from the QEP initiative and athletics. Discussed disadvantages of committees created outside of the Faculty Senate structure, reliability of data presented related to subcommittee requests, and existing Senate subcommittees that could address areas of writing intensive programming and athletics. Committee will determine feasibility of General Education committee addressing writing intensive programming and Enrollment Management committee addressing concerns of clustering of university athletes in certain courses.

Appendix B

Sample Language forthcoming from Dr. David Nikkel

There shall be a Faculty Grievance Assistance Committee to serve as a resource to faculty members in navigating the procedures and processes of the University's hearing and grievance policies. This Committee shall consist of three members, who may serve up to three years; a member who has served three years consecutively must be off the Committee for at least one year before being eligible to serve again. Only former (not currently serving) members of the Faculty Senate, the Faculty Grievance Committee, or the Faculty Hearing Committee shall be eligible to serve. An outgoing Chair of the Faculty Senate, the Faculty Grievance Committee, or the Faculty Hearing Committee will be invited to serve provided an opening is available on the Committee. Other members of the Committee shall be appointed by the Executive Committee of the Faculty Senate.
