    - a. No items
  - 2. AVC for Technology, Resources & CIO – Katrina Blue
    - a. Continuing to provide technical/logistical support for the university community
      - 1. [uncp.edu/keepworking](http://uncp.edu/keepworking): provides access to IT resources/instructions for staff and faculty to work while away from campus.
    - b. Equipment needs ... [Liz] No discussion regarding laptops/docking stations in labs, but conversations via Campus Computing Initiative (CCI) to purchase laptops for faculty rather than desktops.
    - c. International Travel & VPN access follow-up

Now is an excellent time for faculty to provide a heads-up opportunity for DoIT to become more proactive in investigating protocols in other countries concerning IT security, safety and/or restrictions in order to be ready for the time when international travel is possible.
    - d. Collective Software Catalog is being developed to provide a searchable, exhaustive list of the university's software.
    - e. Canvas Addons [Ray] – LTIs
      - 1. [GoReact](#) – this product allows feedback on videos submitted by students. School of Education seeks approval; no accessibility review as yet. Item for future consideration.
      - 2. [Proctorio](#) – this is an online proctoring product. Because of the urgency of need in terms of proctoring, AITC was not included in the approval process.
      - 3. LTIs discussion: Canvas administration was unaware faculty were able to approve LTIs without admin approval. This creates possible accessibility issues; proposal to revoke individual LTI approval after completion of this semester.
      - 4. Canvas and student course incompletes; rather than two-week extension, “incomplete” adds new course shell for Canvas and Registrar codes will automatically extend course time-frame.
    - f. IT Governance: [ISO2700](#) & [NIST](#) standards are being used to develop a framework for UNCP IT Governance. At this point the committee consists of DoIT staff and the chair of AITC. Additional members will be added as the group is established.
    - g. UNCP will undergo an IT Audit in either summer or early Fall.
  - 3. Director of the Office of Online Learning – Miko Nino
    - a. ~1,800 courses converted to online and as a result, consultations issues have now decreased.

- b. Office has been providing just-in-time information to respond to pressing needs. The platforms via Canvas and WebEx have been essential to progress.
- c. New phase of focus is toward professional development support and teaching strategies via Teaching & Learning Center (TLC), online teaching certificate and new program development module to increase number and programs online. Another item is to critically examine assessment strategies and provide information/support to help individual efforts to update and/or improve.
- d. Office has and continues to acquire equipment/space for faculty to develop materials, etc.  
It was acknowledged there are limitations as to the feasibility and advisability of pressing the idea that all things can be done online. There are limitations.
