#### Charge:

The Budget Advisory Committee shall consist of nine members: Vice Chancellor of Finance & Administration, who serves in an ex officio capacity, and members of the General Faculty, one from each Division and two at-large, nominated by the Committee on Committees and Elections and confirmed by the Senate. Membership is for three-year staggered terms, and the chair and secretary of the Committee shall be appointed by the Faculty Senate Chair from its General Faculty membership. It is the Committee's responsibility to develop a comprehensive understanding of the fiscal resources available to the University, their allocations, and their management, within the institutional contexts in which budgetary decisions are made. In this role, the Committee shall serve in a consultative role to the Vice Chancellor of Finance & Administration regarding the University's strategy and management of fiscal resources and ensure that the University meets its fundamental mission, vision, and core values and future aspirations.

IV. Update on current campus budget scenarios and legislative issues – Charles Leffler Charles Leffler and Leslie Bell shared a presentation that was shared last week with the UNCP Board of Trustees. (Appendix A)

Information included an overview of the Board of Trustees being responsible for approving an "all funds budget". The "all funds budget" is approximately 245 million dollars. Information about the UNC Budget process was provided which considers system and campus strategic plans, approved metrics for on-time graduation rates and student debt, revenue projections based on tuition, fees, and auxiliary rates, and campus performance on financial ratios. The UNCP Board of Trustees approved the all-funds budget during last week's meeting.

Information on data and trends was provided. Leslie Bell indicates they will be expanding data analysis. Student credit hours by classification of instructional programs (CIP) was reviewed. UNCP has witnessed growth over the last three years. The growth in the MBA program was highlighted as a program of significant growth. The CIP (from the Delaware Study) will be updated every two years. Campuses are providing updates to Board of Governors to address challenges of using the Delaware Study. Greater data analysis will continue to take place. In addition, this process will continue to evolve.

#### V. Old business

The new CFO, Gabe Eszterhas, to start May 16th.

Sherry Edward, Chair, to rotate off this committee. Sherry was commended for her service to UNCP especially to our committee. Melissa Schaub will serve as the chair of this committee next year. A transition plan will be discussed including identifying members of this committee for next year.
