There was an outstanding question regarding whether faculty were automatically notified (or could be automatically notified) regarding the outcome of a conduct charge. The chair of FIAC consulted with Dr. Dutnell (director of student conduct) to address this question. For conduct charges the faculty member files the report, but the university is the complainant and presents the case. Thus, this information is protected by federal law and releasing information requires the signed release from the individual charged. As such, faculty members are not automatically notified of outcome as they would be with a honor code charge. Faculty members who have questions or concerns about a case should call the director of student conduct (currently Dr. Meg Dutnell).
