VIII. Meeting was called to order at 3:42PM.

IX. Minutes of the August 18th meeting were approved.

XI. Chair's Report

- a. Faculty senate voted on 9/7 to allow committees and subcommittees to determine their own meeting format (F2F, online or hybrid) see new business.
- b. Call for nominations for CHS and ARTS members went out on 9/7 however they are having trouble recruiting candidates.
- c. Faculty Governance discussed but did not take any action to give guidance on which changes passed by the committee must receive Senate approval. This issue will be on the October Governance agenda.

XII. New Business

- a. Name of Faculty research committee p. 81 (via Paul Flowers email query)
 - i. Context: Current Handbook (p. 83) refers to now defunct Faculty Research and Development Committee (FRDC) as involved in grant-funding decisions:
 - 1. "Working with the Faculty Research and Development Committee and the Center for Sponsored Research and Programs, the Provost and Vice Chancellor for Academic Affairs should promote a healthy program of both internal and external funding for scholarly and creative work."
 - 2. Question: Should this Committee reference be changed to Faculty Research Advisory Board (FRAB)?
 - ii. Chair emailed Scott Hicks (Teaching and Learning Center, director), Patricia Cornette (Sponsored Research and Programs director), and Liz Normandy (Associate VC Planning and Accreditation) for clarification.

- 1. Liz Normandy explained that while the FRDC was charged with awarding internal grants, Sponsored Research and Programs now administers the Faculty Summer Research Grants program; the FRAB is not involved in the process of awarding grants.
- 2. Liz suggested simply omitting reference to a Faculty Senate Committee from this section of the Handbook as follows:

 "Working with the Center for Sponsored Research and Programs, the Provost and Vice Chancellor for Academic Affairs should promote a healthy program of both internal and external funding for scholarly and creative work."
- 3. The committee voted to accept the language suggested by Dr. Normandy.
- b. Members voted to establish WebEx as the venue for all future meetings in AY 22-23.
